#### Round table

Lydia Question 1. Incarcerated Individuals at Pill line are, outside and waiting times seems to be taking lot of time. Are there more times available to get dosages?

Asst. Supt. Penrose & HSM Evans – Answer We are Modifying and looking at it due to social distancing. Will work with Captain Rubalcaba further on this.

Question 2. Lydia Any information from Dr. Rainier of the Incarcerated in the EFV for Tuberculosis on Mental health guidance? Are COs getting trained for clues, are you Counting on the staff for this purpose?

Asst. Supt. Penrose Answer Staff are trained at SCCC of behaviors and baselines, we inquire about this through conversations. We are not trained in Mental health. If not, normal base line we pass it along to the Incarcerated Individuals to encourage to seek out guidance from our DOC Chaplain and Counselors.

Question 3. Lydia, do you have a provider onsite?

Asst. Supt. Penrose Answer Mental Health is on site, they do an excellent job, and we commend them on their work. Who is also available upon request per the Incarcerated Individual?

Question 4. Susan Wade- Can we get a new chart of staff Employees? Bethany gone names/ contacts info are needed.

Asst. Supt. Penrose Answer We have had a lot of movement, understand it's hard to track.

Susan Wade Question 5: Are Tier rep- meetings are done Monthly?

Asst. Supt. Penrose Answer - Tie reps meet with CUS monthly, then we have facility quarterly. Taking 2 days with movement of Cohort A and Cohort B movement.

LFC representatives are treated like the Tier representatives, they are contacted and given the chance to ask questions at the meetings, they get a copy of the notes too.

Susan Wade Question 6 Tier Rep Meeting are we provided Quartey tier reps meeting notes.

Asst. Supt. Penrose Answer we must go through them and answers the questions to get them out. All finalized are sent published to the Tier Representatives. Tier rep notes are posted in day rooms except IMU. How I/I will see and know about what was spoken at during the meetings.

Wade-Question 7 we do not get monthly notes only quarterly we might need to have follow-up.

Asst. Supt. Penrose Answer Quarterly only. Items that don't get taken to the Quarterly meeting are resolved by the CUS. We would never get anything done if we did that.

Wade LFC REP Question 8 -Can we be on the phone for this meeting?

Asst. Supt. Penrose Answer we do not have the staff to do this. We do not have the room or take the rooms away from other places.

Wade Question 9: I get it, not the time (TB guys and 60 guy is not to F south and other places that have space to accommodate? Without risk to others.

Asst. Supt. Penrose Answer - Neg pressure room we depend on clinical for all this. We must make sure we don't infect others.

Lydia- Question 10. DOH monitoring/ not by SCCC medications for the Incarcerated individuals. Negative pressure room availability? Are the EFV s sealed off, what about caution of those who are suffering with Tuberculosis in the EFV s. NO Wi-Fi and no one around to talk to. This is a Mental Health issue that needs to be taken seriously.

Asst. Supt. Penrose Answer there does need to be Sensitivity to this matter.

Question 11. Anna- When will gym open?

Asst. Supt. Penrose Answer not closed, when we have custody staff shortage or people calling in sick. We have a high number of transports to local hospitals. Affecting the proper staffing like yard, Rec, and programs.

Question 12 Anna- Rec has never opened,

Asst. Supt. Penrose Answer Pre-covid because Incarcerated Individuals in times.

Anya Questions 13 Fundraiser any coming up?

Van ogle Answer Fundraiser- planning, Counselor Tully from H6 will be taking this over for Graves. No details at this time

Anna Question 14 With having 60 Incarcerated Individuals and a packed facility. It should be a university above bars. How will their idle time be kept busy? With Few work opportunities educational programs.

Asst. Supt. Penrose Answer

SCCC has been limited due to COVID- which is different than other facilities. Change in capacity from pre covid. We have the BPC weekend evening classes. to those not qualifying. We have a lot of programs, jobs 42 garden lifers. Beyond for folks about agriculture/ Sustainability. Bees program, Sage to E. WA. Wheelchair and

Bicycle/ Paints. Cannot even say all of the programs we have currently. We do not have any less, than other Facilities. We might have a different criterion for CI positions. Many of the jobs in CI are for office furniture and steel workers. We have A lot to offer due to cohorts' opportunities is half currently due to running 2 set s.

Tammy Question 15 - Kiosk video visit, user can't be reached. Charged both times several people.

Asst. Supt. Penrose Answer

Video visit other units taking on schedule there is no availability. We have Samuel, Natasha from securest working on these issues.

Diane- Question 16 Amend start up.

Haynes Answer

SCCC has started training this week. A few are headed to Norway in another month for further training.

Asst. Supt. Penrose Answer We are very proud for SCCC to represent this curriculum in WA.

Asst. Supt. Penrose Answer – Amend teaching assists in Mental health in special housing units and trying to help those to adjust and cope with other individuals to move to other population vs staying in max custody. Our IMU used Techniques and were excited to incorporate these new techniques. Isolation creates anxiety and we are helping to addressee these anxieties.

Sarah Leon- Question 17. How are Tier reps' elections done?

Asst. Supt. Penrose Answer They are Elected 2 per Unit, appointed by CUS.

Leon Question 18. Past month no movement to P building and recreation?

Asst. Supt. Penrose Answer Recreation and yard have been stalled at times due to staffing being pulled off to medical trips. We are requesting new hires to alleviate this issue.

Leon-Question 19. Programing and Recreation is vital to their health.

Tamra- Question 20. Mental Health Providers Employees- Psych 4 Associates, are they contracted fulltime/part- time. How many does SCC have and where are they from?

Asst. Supt. Penrose Answer

I do not know that information currently. I will reach out to HSM Evans and HSM Johnson. Due to not being aware of the staffing level.

Lydia- Question 21 Can LFC get an email update on this issue.
