Mrs. Ramsdell-Gilkey presented this case.

Risk assessment scores are in the moderate range.

Mr. Evans was seen for a .100 Hearing at the Monroe Correctional Complex Special Offender Unit on April 20, 2017.

Mr. Evans is under the jurisdiction of the Board in Snohomish County Cause #83-1-00524-2 for Assault in the Second Degree. Mr. Evans also has two consecutive Sentence Reform Act (SRA) convictions for Custodial Assault which are not under the Board's jurisdiction.

Mr. Evans also has prior convictions in Kitsap County Cause 2362 for Robbery, Rape 1 and Robbery.

The Snohomish County Assault in the Second Degree involved Mr. Evans stabbing a correctional officer with two pens. This happened after the Correctional Officer ordered Mr. Evans to cell in after ignoring a direct order from the officer. Mr. Evans was 29 at the time of the offense and is currently 62 years of age.

Mr. Evans last serious infraction was 17 years ago, but he has a history of staff assaults prior to that time. He says God told him to stop assaulting people and that is why he had no new infractions.

Mr. Evans has completed programming available to him to the best of his ability including the Sex Offender Treatment and Assessment Program.

Mr. Evans has two consecutive SRA causes to serve, and he is eligible for the Offender Reentry Community Safety (ORCS) Program.

- **Recommendation:** The panel recommends that he be found parolable to Mason County Cause 91-1-00048-4 on his parole eligibility review date (PERD) of August 14, 2017. He will serve the Walla Walla County Cause 94-1-0002551 after serving the Mason County Cause.
