- Mr. Boot was seen for a .100 Hearing on July 25, 2017 at the Monroe Correctional Complex – Twin Rivers Unit.

Summary Discussion

Mr. Patnode presented this case.

Mr. Boot is under the jurisdiction of the Board in King County Cause 82-1-000826-1 for Rape in the First Degree Count I, Robbery in the Second Degree Count II with a Habitual Criminal Finding. Mr. Boot served on a previous cause in Spokane County Cause 20751 for Burglary in the Second Degree.

Mr. Boot was convicted and also served time for Burglary Second Degree in Pierce County Cause 44940; Burglary Second Degree in Spokane County Cause 20204; Burglary in the Second Degree in Spokane County Cause 20751; and Assault in the Second Degree in King County Cause 82061. These causes have all reached their statutory maximum.

The crimes in King County Cause 82-1-000826-1 involved Mr. Boot attacking and sexually assaulting a women who was delivering early morning newspapers. He entered her car, assaulted her, and drove her around in her car for about one hour. During that time he raped her and took money from her purse then forced her out of her car. He was 29 years old at the time of the offense and he is currently 64 years of age.

Risk assessment scores rate him as a moderate to high risk to re-offend. A Forensic Psychological Evaluation was completed in December 2011 which indicates he does not meet criterial for civil commitment.

Mr. Boot has had five serious infractions during his incarceration with the last one occurring in 2006.

Mr. Boot has completed Moving Forward but struggled with identifying high risk behaviors. He has not completed the Sex Offender Treatment and Assessment Program (SOTAP) because he does not admit to his role in the sexual assault. Due to Mr. Boot's on-going denial of his crimes and lack of participation in sexual deviancy treatment, the Board is recommending 90 months be added to his minimum term.

• **Recommendation:** The panel recommends that he be found not parolable and that 90 months be added to his minimum term.

The Board would like Mr. Boot to remain infraction free and to participate in SOTAP. The Board will see him sooner if he completes SOTAP.

Next Action: Schedule a .100 Hearing 120 days prior to his parole eligibility review date. A new psychological report is required for his next hearing.
