The following list of offenders are scheduled to meet with the Indeterminate Sentence Review Board (ISRB) during June 2016. The ISRB, formerly known as the Board of Prison Terms and Paroles, has jurisdiction over three types of offenders:

- (1) Pre-84 (PAR) - Offenders who committed their crime(s) prior to July 1, 1984 and were sentenced to prison. The board must determine if the offender's rehabilitation is complete and whether he or she is fit for release. If the Board decides to release the offender, the Department of Corrections (DOC) will propose a release plan. The board will review the plan and either approve or reject the plan. If an offender fails to follow the conditions of parole, the board can revoke parole or impose new parole conditions on the offender.
- (2) Community Custody – Board (CCB) - Offenders who committed certain sex offenses on or after September 1, 2001. The board must determine if evidence suggests the offender is more likely than not to commit a new sex offense if released with conditions. If the board decides to release the offender to community custody, the offender must comply with all release conditions that were imposed by the court when he or she was sentenced, as well as any conditions imposed by the board. If an offender fails to follow those conditions, the board can revoke the release or impose new release conditions on the offender.
- (3) Juvenile Board (JUVBRD) - Offenders who committed crimes prior to their 18<sup>th</sup> birthday and are sentenced as adults. The board must determine if evidence suggests the offender is more likely than not to commit a new crime. If the board decides to release the offender on supervision, the offender must comply with all release conditions that were imposed by the court when he or she was sentenced, as well as any conditions imposed by the board. If an offender fails to follow those conditions, the board can revoke the release or impose new release conditions on the offender.
