

Washington State Department of Corrections Notice of Second Public Hearing

NORTH CENTRAL COUNTIES (CHELAN, DOUGLAS, KITTITAS)

North Central Counties (Chelan, Douglas, Kittitas) Virtual Second Public Hearing

The Washington State Department of Corrections will hold a virtual second public hearing to consider the potential siting of two properties in Chelan County for a work release facility. The hearing is open to the public.

Date: Wednesday, October 27, 2021

Time: 6:00—8:00PM

Location: Virtual (Event login details will be provided following registration.)

Background

The Department of Corrections (DOC) is expanding its <u>Work Release program</u>. North Central counties (Chelan, Douglas, Kittitas) is an area that DOC has identified as underserved or unserved for work release beds available for incarcerated persons to transition to the community and is being considered for work release bed expansion.

Washington's work release institutions serve as a bridge between life in prison and life in the community for Washington inmates nearing the end of their sentence. In short, work release facilities are separate and apart from Washington state prisons. They exist to provide participating inmates the opportunity to engage in paid employment or vocational training programs in the community while remaining under DOC supervision at an appropriate facility when not at their job or other pre-approved activity. Incarcerated individuals who complete the work release program are more likely to be successful in maintaining employment, stable housing, and in paying legal financial obligations. Recent research conducted by the Washington State Institute for Public Policy indicates that work release programs have a positive cost/benefit impact; for every dollar spent, \$3.82 is returned to the state.

In 2019, DOC formally initiated a public Work Release (WR) facility site selection process in the North Central Counties. As required under WAC 137-57, the site selection process began with the formation of a search committee, establishment of a Local Advisory Committee (LAC), and ongoing efforts to identify suitable sites. Per the Revised Code of Washington (RCW) 72.65.220 – Facility siting process, when DOC has selected three or fewer sites for final consideration of a department-owned, operated, or contracted work release or other community-based facility, the department or contracting organization shall make public notification and conduct public hearings in the local communities of the final three or fewer proposed sites. This first public hearing was held on Wednesday, August 11, 2021, and a recording of that meeting can be found here. The LAC recommended and Secretary Cheryl Strange gave preliminary approval of both properties to move forward to a second public hearing as required by RCW.

Required notifications were provided to the following:

- (i) All newspapers of general circulation in the local area and all local radio stations, television stations, and cable networks;
- (ii) Appropriate school districts, private schools, kindergartens, city and county libraries, and all other local government offices within a one-half mile radius of the proposed site or sites;
- (iii) The local chamber of commerce, local economic development agencies, and any other local organizations that request such notification from the department; and
- (iv) In writing to all residents and/or property owners within a one-half mile radius of the proposed site or sites.

Note: A communication plan developed by LAC members provided for additional notifications to be sent to other surrounding community stakeholders that may not be captured by the required list noted above.

Sites under consideration

In a state-wide effort to search for properties a Request For Proposal (RFP) #12192, Work Release Program Expansion Project No. 2020-311 A (1) was issued in late December 2019. The RFP requested proposals for suitable properties to expand the DOC work release program into four underserved counties (Pierce, King, Snohomish, and North Central Region). The following two proposed facilities are being considered to support Work Release Expansion in one of Washington States most underserved areas, the North Central region.

<u>Chelan County Regional Jail (CCRJ) Annex – 401 Washington St., Wenatchee, WA</u>

The CCRJ Annex is proposed to be designed to house both male and female residents and is a candidate to serve a minimum of 32 male and 8 female occupants (40 total beds). Access to the facility is via the northeast from the existing shared Chelan County complex parking lot. The City of Wenatchee is the primary Authority Having Jurisdiction (AHJ). The AHJ is responsible for interpreting and enforcing locally adopted environmental, zoning, building, mechanical, plumbing, and other codes, and standards. The property is zoned Central Business District (CBD). Based on discussions with the AHJ a DOC work/training release facility may be permitted outright in the CBD zone.

Deaconess Building – 300 Okanogan Ave., Wenatchee, WA

The south wing of the Deaconess Building is proposed to be designed to house both male and female residents and is a candidate to serve a minimum of 120 occupants. Access to the facility is via the south from an existing dedicated parking lot. The City of Wenatchee is the primary Authority Having Jurisdiction (AHJ). The AHJ is responsible for interpreting and enforcing locally adopted environmental, zoning, building, mechanical, plumbing, and other codes, and standards. The property is zoned Residential Moderate (RM). Based on discussions with the AHJ, a DOC work/training release facility is considered a Conditional Use in the RM zone and is designated an Essential Public Facility (EPF).

As required by <u>RCW 72.65.220</u>, DOC will be holding its second and final virtual public hearing on Wednesday, October 27, 2021, from 6:00-8:00PM. This meeting will provide an overview of the Work Release Expansion program, proposals and alternatives of the selected sites, and an opportunity for the public to provide written or oral comments.
