	The WRAP system restraints are the agency standard. No other makes or models will be considered.		
	<b>Bag</b>		
1.1	Tactical Bag/Riffle Sling Carrying Strap – Bag material: 100% Polyester PVC (Poly Vinyl Coated) Material. Riffle Sling Material: Heavy Nylon 2 inch webbing strap.		
1.2	Color coded bag divider inside bag to separate restraint components.		
1.3	Break-away plastic connectors from riffle sling to body of bag.		
	<b>Ankle Strap</b>		
1.4	Size: Approximately 3 inches wide by 18 inches long.		
1.5	Two 8 inch carrying handles, hook and loop (Velcro) system with additional security flap at end of the strap

1.6	2-inch rectangular ring for secure fastening with built-in rotating sheath.		
	Leg Restraint		
1.7	Size: Approximately 3 ft. by 4 ft.		
1.8	Contain 3-steep bars sewn inside restraint with ample padding and proper crimping to avoid leg discomfort

1.9	3-strap locking buckle/strap fastening system with reinforced cast iron buckle covers.		
1.10	Designated key open access to buckle covers.		
1.11	Designated application markers/wording on device.		
1.12	Repelling carabineer at bottom of leg restraint in place to hold tether from harness.		
1.15	Reinforced stitching throughout restraint – 69-gauge nylon thread.		
1.16	Locking buckle straps fasten to the body of the restraint during storage with Velcro.		
1.17	Contains 4 carrying handles (2 on each side of Leg Restraint).

1.18	Contains 1 security ring on the upper center of the Leg Restraint just below the groin.

1.19	Size: Approximately 18 inches by 5 feet.		
1.20	Main section of harness contains two 18 inch straps and a 12 inch by 10-inch section of material that drapes over shoulders and is secured around body with additional set of straps that contain locking buckles with cast iron covers that only open with designated key.		
1.21	Contains doubled and reinforced stitching.		
1.22	Contains a tether from front of harness and connects to carbineer on the leg		
1.23	Includes a sealable rear holding pouch on rear of harness.		
1.24	Contains a locking carbineer on rear of harness that receives both hinged and linked		
1.25	Rear of harness contains an additional solid security ring to secure handcuffs in rear of body
