- An updated prosecutor recommendation was received. The Prosecutor was not in support of releasing Mr. Gallegos.

- Roy Gallegos was seen for a .100 hearing on February 11, 2025 at the Stafford Creek Corrections Center.

- **Summary Discussion**
Jeff Patnode presented the case to the full Board.

- Roy Gallegos is under the jurisdiction of the Board for their conviction of Murder in the first Degree and Statutory Rape in the First Degree in Pierce County Cause 84-1-00556-6.

Mr. Gallegos entered the bedroom of the youngest daughter of his girlfriend. He raped her and then in an attempt to quiet her, he places a pillow over her

face which causes her death. He then turns to the sisters of the victim and raped them. He was 21 years of age at the time of the crime and is currently 62 years of age.

Previous Criminal History:

Mr. Gallegos' previous criminal history consists of Malicious Mischief and eluding police.

Risk assessments show him to be a low risk to re-offend.

Mr. Gallegos' last serious infraction was in 1996.

Mr. Gallegos has completed Redemption, Life Skills, and numerous educational/vocational programs.

Mr. Gallegos plans to use the DOC voucher program upon release.

- **Decision:**

The panel recommends Mr. Gallegos move to his next cause.

- **Reasons:**

- Mr. Gallegos has managed his behavior and not incurred a serious infraction since 1996.
- He has been programming when available and has been involved in prison employment.
- He indicates he is willing to participate in the DOC SOTAP when he is eligible.
- The Board makes this decision to allow Mr. Gallegos to access offender changes programs to reduce his risk and address his rehabilitation.

- **Recommendations:**

- Sex Offense Treatment and Assessment Program (SOTAP), if he is eligible
- Sober Support Groups
- Mental Health Treatment (including any prescribed medications)
- Thinking for a Change, Redemption, Bridges to Life, Alternatives to Violence, Domestic Violence Treatment
- Remain infraction free and have positive interactions with staff

- **Next Action:**

- Parole to consecutive cause. Schedule .100 Hearing 120 days prior to his PERD. The Board makes this decision to allow Mr. Gallegos to

access offender changes programs to reduce his risk and address his rehabilitation.
