- An updated prosecutor recommendation was not received.
  
- Dani Holder was seen for a Release Hearing on February 4, 2025 at the Monroe Correctional Complex.
  
- **Summary Discussion**  
Jill Getty presented the case to the full Board.
  
- Dani Holder is being seen by the Board for her convictions of Murder in the First Degree in Walla Walla County Cause 95-1-00040-9.

Ms. Holder killed her sister and friend when they got home from school. She was 15 years of age at the time of the crime and is currently 45 years of age.

**Previous Criminal History:**

Ms. Holder has no prior convictions. She self-reported running away, suicide attempts as well as fumes from glue and gasoline.

Risk assessments show him to be a low moderate risk to re-offend.

Ms. Holder's last serious infraction was in January of 2020.

Ms. Holder has participated in mental health services (DBT skills), Toastmasters, and Alliances; completed Associate of Applied Science Degree in Business Management; ACCI Correspondence Course Re-entry Life Skills Domestic Violence; self-directed courses in Houses of Healing, Stressful Life Events, Domestic Violence, Aggression Replacement Therapy and Anger Management; institutional employment.

Ms. Holder will utilize the Journey Project.

- **Decision:**  
The panel recommends Ms. Holder be released.
  
- **Reasons:**
  - Participating in mental health services (DBT skills), Toastmasters, and Alliances; completed Associate of Applied Science Degree in Business Management; ACCI Correspondence Course Re-entry Life Skills Domestic Violence; self-directed courses in Houses of Healing, Stressful Life Events, Domestic Violence, Aggression Replacement Therapy and Anger Management; institutional employment.
  - No serious infractions in the last five years.
  - 3pts/Low-Mod Static 99R; 7pts/Mod Stable 2007; Bin 6/9 VRAG; Low-Mod HCR-20v3.
  - Reasonable release plan.
  - Ms. Holder has worked to address the areas of concern identified in her last ISRB hearing through her ongoing participation in mental health services and other programs. In addition, she received a favorable report from her mental health provider.
  - The September 2024 Psychological Evaluation opined Ms. Holder was a moderate risk for future violence and a reasonable candidate for release.
  - She has not received any serious infractions in several years, indicating she may be capable of abiding by conditions of community supervision.

- **Recommendations:**
  - Mental Health Treatment/Individual Counseling
  - Sex Offense Treatment and Assessment Program (SOTAP), Community Phase
  - Strong Controls around minor contact
  - Strong controls around relationships
  - Electronic Monitoring
  - Alcohol/Drug restrictions
  
- **Next Action:** Submit an Offender Release Plan (ORP) for consideration.
