- Kimberly Johnson was seen for a .100 hearing on April 30, 20240 at the Monroe Correctional Complex.
- Summary Discussion

Jill Getty presented the case to the full Board.

 Kimberly Johnson is under the jurisdiction of the Board for their conviction of Rape in the First Degree and Assault in the First Degree in Clallam County Cause 6363.

Ms. Johnson sexually assaulted an unknown, adult female in her midtwenties. She was 22 years of age at the time of the crime and is currently 64 years of age.

Previous Criminal History:

Ms. Johnson was convicted of Burglary in January 1979.

Risk assessments show her to be a low-moderate risk to re-offend.

Ms. Johnson has not received any serious infractions in the last five years of incarceration.

Ms. Johnson has participated in several support groups during her incarceration as well as maintaining employment.

Ms. Johnson's release plan is to utilize the Journey Project for support.

Decision:

The panel recommends Ms. Johnson be conditionally parolable to a Mutual Reentry Plan.

Reasons:

- Involvement with mental health services/Building Better Boundaries and Alliances groups; scheduled to begin SUD treatment on 5/6/24 which should be completed prior to ERD; institutional employment; previously completed SOTAP in 2021.
- No new serious infractions since 2012.
- 2pts/Low-Mod Static99R; 3pts/Average Static 2002R; 17pts/PCL-R (below cut-off)
- Release plan to the Journey Project.

Recommendations:

- Sex Offense Treatment and Assessment Program (SOTAP), Community Phase
- Strong controls around alcohol use
- Strong controls around drug use
- Strong controls around relationships
- Electronic Monitoring
- Sober Support Groups
- Mental Health Treatment

Next Action:

• Schedule a .100 Hearing 120 days prior to PERD. The Board requests notification of any incurred serious infractions.
