- Simon Dearbone was seen for a .100 hearing on July 30, 2024 at the Reynolds Re-Entry Center.

Summary Discussion

Elyse Balmert presented the case to the full Board.

• Simon Dearbone is under the jurisdiction of the Board for their conviction of Murder in the First Degree in King County Cause 65631.

Mr. Dearbone and two juveniles lured Mr. Dearbone's minor male cousin into the woods where Mr. Dearbone murdered him. He was 28 years of age at the time of the crime and is currently 79 years of age.

Previous Criminal History:

Mr. Dearbone's criminal history began in 1969 with Indecent Liberties, and also includes Assault and Burglary

Risk assessments show him to be a low risk to re-offend.

Mr. Dearbone's last infraction was in 2021.

Mr. Dearbone has significant family, tribal and veteran's support. His plan is to use tribal benefits to secure housing.

Decision:

The panel recommends that Simon Dearbone be released to the community.

Reasons:

- Completed a re-entry class since his last Hearing. Previously completed SOTAP, STOAP Aftercare, Bridges To Life, Thinking For Change, Redemption, Substance Use Disorder and Victim Awareness.
- He has community support, access to Tribal and Veterans Administration resources.
- Static-99R 1-point Low Risk, ESRC Risk Level I.
- He has not incurred any new Serious Infractions.
- He has support in the community and access to tribal and Veterans Administration.
- He recognizes his triggers and can identify interventions.
- In the psychological evaluation by Dr. Robtoy, she indicates that Mr.
 Dearbone has "demonstrated some evidence of maturation and/or
 rehabilitation since his last hearing before the Board." She further
 indicates, "he is taking steps in the right direction to become a
 reasonable candidate for release to less restrictive settings."
- His age and physical health may reduce his risk.

Recommendations:

- Sex Offense Treatment and Assessment Program (SOTAP), Community Phase
- Strong controls around alcohol use
- Strong controls around drug use
- Strong Controls around minor contact
- Strong controls around relationships
- Internet Monitoring

- Electronic Monitoring, first 90 days
- Sober Support Groups
