A discussion took place regarding why the number of denied ORP (Offender Release Plans) is higher than normal. The ORPs being denied recommendations from the Community Supervision field staff, not the Board.

- II. Chairs Report Jill Getty has been appointed to be a Board Member by Governor Inslee, effective March 1, 2023.

III. Executive Director Report:

- Legislative Update (Bills of Interest):
 - SB 5451 (companion bill 1325) This bill would raise the age to 25 (from 18) for those who have committed First Degree Aggravated Murder. Those cases would still petition the Board for early release.
 - HB 1383 Amends RCW 9.94A.730. Currently this RCW affects those whose crime was committed prior to their 18th birthday and sentenced as an adult. HB 1383 recommends raising that age to 24 from 18.

- HB 1396 Allows those who have been sentenced to aggravated murder up to the age of 21 to go back to the court for resentencing. Raising the age from 18 to 21.
- O SB 5270 Prohibits the Department of Corrections (DOC) from assisting with an individual's arrest, detention, transfer, interrogation, or deportation in any manner for an immigration enforcement purpose. Prohibits DOC from recording certain information or allowing any federal immigration authority to access DOC's databases. Prohibits DOC from using immigration or citizenship status to deny privileges or participation in programs, or to determine custodial classification. Removes limitations or exclusions on participation in certain DOC programs and services for persons subject to deportation. Repeals authorization for conditional release of certain individuals to the custody of Immigration and Customs Enforcement.
- HB 1189 Expands and modifies the membership of and process requirements for the Clemency and Pardons Board (CPB). Establishes a process for qualifying persons to petition the CPB for conditional commutations. Requires the CPB to recommend to the Governor those conditional commutations be granted in certain circumstances. Authorizes the Department of Corrections (DOC) to supervise persons granted conditional commutations. Expands the eligibility criteria and modifies electronic monitoring requirements for persons granted extraordinary medical placement by the DOC.
- SB 5135 Restricts the use of solitary confinement in state correctional facilities and long-term private detention facilities except when necessary for emergency purposes, medical isolation, or when the person voluntarily requests such confinement. Establishes limits on duration, hearing processes, standards around living conditions, and access to activities outside of the cell, necessities, communication, personal hygiene, and medical care for persons in solitary confinement. Requires development of rules, policies, and transition plans by certain dates. Requires collection and reporting of data on the use of solitary confinement.
- HB 1541 This bill is the Nothing About Us, Without Us Act. This act increases access and representation in policy making processes for people with direct lived experience. This bill does not directly affect the Board.
- Strategic Planning Feedback Staff reported that the session was well received.
- **Position Update** An update was provided on the open positions.
- IV. **Board Meeting Minutes** The Board Meeting Minutes dated January 9, 2023, and January 23, 2023, had some adjustments and were approved with the adjustments.
