II. Updates from staff -

- Records Mrs. DeBower announced that a records staff from DOC Headquarters passed away.
- Juvenile Case Ms. Balmert reported there was a juvenile recent case that did not have all the documentation that was needed for the hearing. We can request RDA pull the individuals who have been through Green Hill Juvenile facility in order have the information to know to be able to request the documentation.
- Added Condition Ms. Busch submitted a new possible condition to be added to the set of conditions currently used. The motion was moved to add the condition, none opposed.

III. Chairs Report:

- **Budget** The Hearing Investigator position and Program Specialist position that were submitted in Legislation were approved.
- Legislative Bills:
 - Gate money was increased to \$300.
 - Life without parole was removed.
 - DOC was awarded money to cover hiring more CD Treatment staff.
- May is Corrections Pride month. It is a month that is historically to celebrate the work that state employees do.
- Kentucky DOC Staff will be visiting the Board to learn about the Structured Decision-Making Framework (SDMF).

IV. Executive Director Report:

- The Hubbard Decision Staff had a brief discussion about the recent Hubbard Decision. Effective April 27, 2023, courts can no longer modify conditions of supervisions after sentencing. It is likely the Sex Offender Policy Board (SOPB) will get involved with the Hubbard Decision. The SOPB is a board that is a group of experts who can be called upon to by the Governor to review a concern regarding decisions that are made on Sex Offender cases.
- SOTAP Outcome Study The State of New York initiated a project called Project Greenlight. A study was completed to measure the success of the project. It was determined that the project was not as successful as they thought. Washington State made the decision to conduct a study to measure recidivism amongst participants of the Sex Offender Treatment and Assessment Programs (SOTAP).
- JUVBRD & Navigation Services Navigation Services staff gave a presentation regarding the reentry process.

V. April 2023 Meeting Minutes:

• Ms. Balmert moved to approve the minutes and Mrs. Getty seconded the motion. Approved edits will be completed and posted.

VI. Board Member Reports

• Individual Release Plan/Case Manager Job Aid – Mrs. Ramsdell-Gilkey discussed how the Individual Release Plan and the Case Manager Job Aids will be used.

Records staff will be attaching the Case Manager Job Aid document to the hearing notification and the hearing docket. The intent of the Case Manager Job Aid is to assist staff with how Board Hearings are conducted to help in the success of a thorough hearing.

The Individual Release Plan document will be attached to the hearing notice and needs to be returned to the Board a minimum of two weeks prior to the hearing so that it may be included in the hearing packet. The intent of providing the incarcerated individual with the Individual Release Plan early in the process is to assist in a successful release.

- ISRB Communications:
 - Ms. Balmert, Ms. Getty, Mr. McNally, and Ms. Torrence met with DOC Communications staff to discuss the Board's ability to improve internal and external communication.
- Association of Paroling Authorities International (APAI) 2023:
 - Nine staff from the Board attended the APAI Conference in Kansas City, Missouri in April. The Board will be hosting the APAI 2024, in Bellevue, Washington in May 2024.
