II. Chair's Report

• Governor Ferguson has begun the process of appointing new staff. Tim Lang has been appointed as the new Secretary for the Department of Corrections.

Mr. Lang is familiar with the work of the ISRB.

- Interviews for the Executive Director position will be conducted within the next couple of weeks.
- The Legislative Session will start January 13, 2025, and end April 27, 2025 as this
 is a long session year. It was noted that there are a few bills that may impact
 ISRB.
- The current double-fill positions within the ISRB are scheduled to end February 1, 2025.
- As a result of the meeting conducted with the staff from the Center for Effective Public Policy (CEPP), the ISRB will meet with Community Corrections Division on a quarterly basis to increase communication and collaboration. The first meeting is scheduled in January.
- Structured Decision-Making Framework (SDMF) Report Research was completed on the SDMF work being done. The report shows that the SDMF is being used successfully. Ms. Rongen and Board Members will meet with the staff who developed the SDMF for a debrief.

• Ms. Getty presented on a webinar with other states conducted by the staff from CEPP. The main topic was conditions of supervision.

- Staff from SOTAP met with the ISRB staff to continue with our communication and collaboration between entities.
- J&S Project Update The administrative staff are working on auditing the ISRB cases in OnBase to assure the J&Ss are in the Individual's folders and are filed with the correct code. They have processed approximately 410 cases out of the 3,000+ cases.
- Travel Condition Review the condition noted that Individuals had 3 business days prior to scheduled travel into an Exclusion Zone. The condition was edited to 5 business days.
