



Releases of Offenders 2002-2011 with Review Status Listed

- The list of offenders released between 2002 and 2011 went through a review process to determine the newly calculated release date. While the research done for the initial determination was extensive, it was not as exhaustive as the previous multiple reviews for offenders releasing between December 2011 and 2015. Therefore, it's possible that some of the provided release dates may be imperfect. No additional reviews are planned.

- There are 118 cases for which the department will not calculate new release dates because of the extensive archival research that would be needed to complete the analysis. The 118 cases have a review status of "Review Completed/No further action".

- The department prioritized re-incarcerating offenders released from December 2011 to December 2015. Corrections determined it could not re-incarcerate offenders released between 2002 and 2011, based on case law that places limits on how far back in time the department could go without violating fairness and liberty principles and due process rights.
