

<p><b>Type of Court Appearance for Resentence</b></p>	<p>In Person:</p> <ul style="list-style-type: none"> <li>• Court Order for Transport for a specific date and time of hearing and statement that the individual will be returned to DOC upon completion of the proceedings. <ul style="list-style-type: none"> <li>○ DOC requires 14 days to transport the individual from DOC to the county jail.</li> <li>○ Dated/Signed by a Judge.</li> <li>○ Filed with the Clerk.</li> </ul> </li> </ul> <p>Virtual/Telephonic</p> <ul style="list-style-type: none"> <li>• Complete <a href="#">DOC 02-027 Virtual/Telephonic Hearing Request</a> form, and submit to the facility <a href="#">Legal Liaison Office</a> a minimum of 7 days prior to the hearing.</li> </ul>
<p><b>Reentry Resources</b></p>	<p><b>Individuals who are resentenced and are immediately released (defined as within 90 days of an amended Judgment and Sentence (J&amp;S)) are provided the following reentry support:</b></p> <ul style="list-style-type: none"> <li>• An assigned Resentencing Specialist that assists the individual with their Individual Reentry Plan, essential needs, and provide referrals for resources, programming, and community support.</li> <li>• Housing voucher, cell phone, backpack with basic hygiene items and release money on the day of release.</li> <li>• Support from a Continuity of Care Coordinator, who assists released individuals with healthcare needs such as health insurance, medication and medical equipment and community appointments.</li> </ul> <p>Prior to a transfer to a jail and/or resentencing hearing, the Resentencing Specialist may meet with the individual, Classification Counselor, defense attorney and any others that are in support of the individual’s transition to plan for a potential immediate release.</p>
<p><b>DOC Release</b></p>	<p><b>Following a resentence, DOC will determine which sentences are being served and complete the time calculations. An individual may be required to return to DOC for the following reasons:</b></p> <ul style="list-style-type: none"> <li>• To complete the confinement term of the resentence.</li> <li>• To complete the terms of other sentences.</li> <li>• To release in lieu of earned time, per RCW 9.94A.729(5)(a) when a term of community custody was imposed.</li> </ul> <p><b>If the Court intends for the individual to be released the same day of the resentence, please consider the following:</b></p> <ul style="list-style-type: none"> <li>• Jail release: The individual will need to arrange to ship or pick up their property from the facility. Their release of funds money, account check and cell phone will be mailed to their release address.</li> <li>• Prison release: If the individual had a virtual hearing, the documents would need to be sent to the facility by 3:00 pm to ensure that the individual will release with release of funds money, account check, cell phone and backpack.</li> </ul> <p><i>DOC may authorize a release from the county jail when the court determines that the sentence was served in full and to release when only serving on the sentence that is resentenced or the sentence is the longest running sentence being served.</i></p>
