BSRC is housed in a building that was built in 1910 in the heart of downtown Spokane. It is near health care services, substance abuse treatment and is on the main transit line. The primary goal is to improve public safety by positively changing lives, building positive relationships with family and providing residents with the knowledge and skills necessary for success in the community.

Residents who meet the screening criteria may be transferred to BSRC 12 months before their earliest release date. The facility is operated in partnership with a contract agency, The Transition House, that provides 24/7 safety, security and food services. The building is owned by the Department of Corrections.
