## Current Status

### Testing Among Incarcerated Population

Because of the variety of ways testing occurs, consistently and accurately reporting testing numbers can be challenging. Given the more robust availability of testing in the community and within our state's correctional facilities, the Department is working to determine the best way to share accurate numbers regarding the testing of incarcerated individuals and the previously displayed testing data has been removed from the [DOC COVID-19 Data webpage](#).

Testing of the incarcerated population is conducted per the department's [COVID-19 Screening, Testing, and Infection Control Guideline \(pdf\)](#). Incarcerated individuals are tested if they are identified during contact tracing, self-identify symptoms and/or if they are identified as being symptomatic. Individuals who test positive for COVID-19 are then appropriately placed on quarantine status or in medical isolation, per the department's [COVID-19 Screening, Testing, and Infection Control Guideline \(pdf\)](#), depending on whether they are symptomatic or asymptomatic and are kept separate from healthy individuals.
