# Corrections' COVID-19 Bulletin

February 18, 2022 Bulletin 124



## **Current Status**

The Washington State Department of Corrections' (DOC) Prisons and Work Release facilities are seeing a promising decline in COVID-19 impacts with 11 currently on outbreak status. There were 20 on outbreak status on January 24, 2022. DOC's priority is the health and safety of staff and everyone in its care and custody.

DOC has been using the Incarcerated Individual Betterment Fund (IIBF) to do a variety of things for incarcerated individuals to help the time pass more smoothly. Additionally, a <u>message was sent to incarcerated individuals and family</u> <u>members</u> on February 11, 2022, that provided an update on DOC's response to COVID-19 and comfort items provided through IIBF.

Visitation at prisons and work release facilities continues to be suspended, with a re-evaluation date of March 3, or sooner. <u>Read more here.</u>

Each prison and work release facility on outbreak status sends out a weekly status update message, that can be viewed on the department's <u>Significant Events Timeline (SET</u>). ## **Prison Facilities**

Starting January 24, 2022, DOC will be including active cases from the last 14 days rather than confirmed cases in the last 30 days. This is in an effort to provide the most current, relevant information possible in the bulletin. #### **Facility-Wide Outbreak**

#### **Airway Heights Corrections Center**

Incarcerated

- Active incarcerated cases: 100
- Total incarcerated cases to date: 2,930
- Food Service returned to a hot breakfast Tuesday, February 15. Effective February 18, incarcerated workers processed through H-Foyer will be receiving Grab and Go Hot breakfast.
- Laundry services will be on a temporary modified schedule for the week of February 21, due to the Presidents' Day holiday.
- Portable phones are used in living units that are on single cell cohort schedules and in the Regional Care Facility.
- Hard line phones are used in living units with medical isolation individuals, the alternate housing location in the gym and in the MSU living units per cohort schedule.

#### Clallam Bay Corrections Center

#### Removed from outbreak status February 17.

#### Incarcerated

- Active incarcerated cases: 0
- Total incarcerated cases to date: 411
- Laundry continues as normal.
- Phone access in medical isolation continues with portable phones. Those on quarantine have an hour in the dayroom twice a day for phone access.
- Virtual Hearings will resume as per normal operations.
- Education will be in-person on M, T, F per the callout.
- Recreation will be per the normal schedule.

#### **Coyote Ridge Corrections Center**

#### Incarcerated

- Active incarcerated cases: 24
- Total incarcerated cases to date: 944
- Portable phone access has been utilized in alternative housing and medical isolation.
- Laundry continues on normal schedule.
- February 15, C-Unit was removed from quarantine status.
- February 16, B-Unit B-Pod was removed from quarantine status.
- MSC Units G, and B A-Pod continue outbreak status and will test weekly. Recovered individuals do not test at this time.
- We are giving yard time as staffing allows for B A-Pod, C, D, E, I, H and F A.
- Grab and Go meals started on February 18, for Units C, D, E, H and I.

## Larch Corrections Center

- Laundry carts are sent and picked up daily Monday-Friday. Laundry returns the following day.
- Phone access MCC is starting unit movements earlier in the day to provide more opportunities for phone access.
- SOU F Unit will be tested today
- TRU A Unit will be tested Friday, February 18.

- Olympic Unit will continue to be designated as a Limited Area Outbreak status at this time.
- Phone access available inside and outside of units by cohort. Access available several times a day.
- Laundry goes out and is returned daily.

- Laundry operations have been utilizing DOC staff when shortages occur with incarcerated workers.
- Phone access continues on a rolling schedule for living units based on unit and cohort size with access either every day or every other day.
- Conducted a vaccine clinic February 17.

- Placed on outbreak status February 17 because of two positive COVID-19 cases.

#### Staff

- Active staff Cases: 0
- Total staff cases to date: 3

#### Progress House Work Release

#### Incarcerated

- Active incarcerated cases: 0
- Total incarcerated cases to date: 52
- Residents are allowed to take scheduled in breaks in the yard as a cohort group (residents residing in the same room) to allow for more time outside.
- Residents have access to cell phones to increase communications with staff, friends, and family.

- Total staff cases to date: 8
