Plans for hiring porters for VR who clean, floors, tables, childrens' play area & toys & strip out area. The game shelf has kept the area tidy - thank you!
No VR porters at WSRU as of January 2020.	Cleaning of VR children's play area.	Assoc. Superintendent Padilla directed Sgt. Knox to purchase toys for babies & toddlers as recommended by Daniellle White and other parents with small children.
Cleaning of EFV trailers	Deep cleaning & maintenance of trailers is not being done on a regular basis. Update 2-1-20 - Cleaning of the EFV trailers was discussed. Suggestion to develop a checklist for those cleaning the trailers. Captain McNeese requested feedback on the cleaning of the trailors. A draft checklist of cleaning to be brought to the next meeting for discussion.	Lt. Bratton now has cleaning crews in place for cleaning EFV trailers on Thursdays. Cpt. McNeese said she would make the list of tasks for deep cleaning available as well as the schedule. Thursdays are the cleaning days. Deep cleaning includes shampooing carpets, upholstered furniture & sofa pillows, stripping/waxing floors, cleaning windows, bleaching toilets, showers, sinks. It takes more than 40 mins. Trailers need routine maintenance as well. Ex: Windows in Trailer 2 are bowed out.
