Kosher Diets	The menu has been inconsistent for the last few weeks. Someone pointed out that the fine print of the menu states "Menu subject to change," but can there be a notice for the guys on Kosher diets?	The following was an email from CI, it was a vender issue. CI Foods would like to inform you that we have a situation with our vendor for Kosher meals. With the current situation in Gaza, our vendor has prioritized sending a good portion of their production to that region. Though we have orders in with them we have been back ordered. OCC had to do some substitutions. We now have all the meals listed on the menu except the Salisbury steak and the menu should be more consistent. Please use your Food committee members for future food related issues.
Internet Router on HOH B tier	The facility says Securus Securus says facility. It has been broken for about 8 months. This interferes with phone calls, media and even educational apps meant to be available for our incarcerated loved ones. I've reached out to	Repaired- Security Specialist Marc Thomas has been working with Securus on facility complaints and was able to get the technician to fix the router.

Phone Booths	Two of the four phone booths in HOH unit are unusable and don't seem to be a priority to be fixed. What is being done about this?	Repaired- Security Specialist Marc Thomas has been working with Securus on facility complaints and was able to obtain replacement phone.
Chaplain	When is a new Chaplin being hired?	In progress. We have made a conditional offer and if everything works out, we will have the chaplain within the next two weeks.
Vending Machines	Better options for Visit room vending machines and/or at least keeping the current options consistently stocked.	The vendor, Peninsula Bottling Company provides OCC with what they have. We make suggestions however OCC does not have control of their products.
Dental Care	Easier access to dental care- When will the mobile dentist roll out?	We received the mobile dental unit from the manufacturer last week and are currently working staffing model and required training.
Unit Windows	Are there any updates on the window film for the units?	No, the project fell off the priority list (replacing water heaters, roofing, repairing walkways and floors, building rehab and all the security and safety maintenance requests.

New business

Topic	Discussion/Key points	Next steps
Internet Connection	There have been ongoing issues with the internet connectivity. Many individuals have experienced days with no connection, leading to missed birthdays and canceled video visits. This can be quite discouraging, especially when preparations are made for a visit that ultimately fails because of connectivity problems. The administration has a strong connection during Zoom meetings, and family members often have a good signal on their cell phones while at the facility. It raises the question of why our incarcerated loved ones	I share your frustrations as we have experienced the same unreliability. When there are reported outages with Securus connections, notifications are made to the service providers. Both Securus and CenturyLink have a vested interest to quickly resolve the issues based on lost revenue and reputation.

Vending Machines	There are concerns about the vending machines, particularly those offering cold foods like hamburgers and sandwiches. Frequent power outages result in spoiled food, leaving little in terms of nutritional options. It seems that one vending machine is consistently out of order, further contributing to this issue.	We do have a process to monitor the temps in the refrigerated units as well as resetting them when there are power outages; unfortunately, the temps maybe within the acceptable range when the staff check on them so the units may not re-set. Our Plant Manager is purchasing a 20-amp back-up system in hope to resolve the electrical issues causing the machines to fail.
Elections	Schyler Robinson has offered to continue being OCC Family Co-Chair. OCC needs representation at Statewide Family Council Meetings and any interest in Family Secretary.	Ms. Robison will continue to be OCC Family Co-Chair. Paloma Valero accepted the Statewide Family Council Representative for OCC. Elena will reach out to Charissa Reno, SFC DOC Co-Secretary to get Ms. Valero on the calendar invite to attend SFC.
Religious Items	No longer allowing people to mail out beadwork/religious beaded items. Since it's not stated in the policy that it is against the rules, it's causing some confusion and conflict in the Native American community.	There has been some confusion on sending out beading work or hobby craft-type work. The CPM reached out to HQ Religious Program Manager who agrees with the direction noted below. Hobby craft items-Must have an approved hobby craft permit and materials are to be purchased from your personal account, through the recreation department who will track the purchase, and will be mailed out through recreation department upon completion. Religious craft items-These are for gifts at the Pow Wow (upon completion to be stored in the chapel), or to be put on your

personal religious property (Must meet policy allowed items and be approved through the Religious Coordinator prior to making. The item(s) will be placed on property matrix at the conclusion of completing item).

Religious hobby craft type items will not be sent out in the mail from this point on.

The CPM will make consideration around pow wow to send gifts out to those sponsors/family who were unable to attend (and of course that I/I will have to be a participant of the native American religious activities. We are not sending out bead work year-round, the bead program is for them to make pow wow gifts and/or items for their own use.

Currently OCC is recruiting friends and family members of incarcerated individuals that are on approved visit list to be a part of our local family council. Family councils advise, collaborate, problem solve, and partner with the Department and the community to improve communications with the Department, create opportunities to strengthen family and community connections, improve quality of life for those incarcerated, promote successful reentry, provide family input on related policies and operational memorandums, and address local and statewide issues/concerns that affect a broad range of those incarcerated and their families. Family is broadly defined to include immediate, extended, and elected family members, such as romantic partners, friends, neighbors, and clergy. Department employees and council members work together to bring awareness to the family councils to encourage participation. Each prison facility maintains a Local Family Council (LFC). Family council meetings provide opportunity for family members to ask questions, get information, and share their perspective of the facility. All approved visitors may attend a family council meeting. Your family members may find additional information on our agency website or by contacting my office directly.
