Mansford: We have a new OA in CPPC, Tracie Kerrie. The next Family Fun Night is March 15th with St. Patrick's Day themed arts and crafts project. Our Significant Others event is on March 16th. Orders have been submitted and the preevent workshops will be announced soon.

The Read to Me/Video Gram program will be starting again shortly.

Spring Event is coming in April. It is child friendly event.

Family Member: Is there a way to split these bigger events into 2 groups (cohorts) so more people can participate? The events fall on the same cohort visit day most of the time, is there a way we can change that? Mansford: The reason we have it for 1 day is partly due to funding. If we do 2 days we would need to double our funding requests. I do take the switching days and being able to stay as an excellent suggestions.

Family Member: Families have been working really hard to collaborate. How can we make collaborate more collaborative? This has been a challenge.

Mansford: If there are things coming from HQ that we are not doing please let me know. Also you can email or call me to discuss things as well.

Family Member: Is there a cut off for when people can sign up for the volunteer and sponsor training?

Mansford: Due to background checks and such, along with approval above and back down I would say March 8th. The training will be from 9:30 -11

Mansford: I typically try to give a month notice for approval but if we do go too far out it make a little bit of chaos on the list. We do have a somewhat mobile population (going to camp, changing facilities, etc.) Jacobsen: The original kiosk goes out for 2 weeks 60 days prior to the event. Once we have the approval, we send out the kiosk and we also build a waitlist.

My understanding is that urgent care did some amazing things but there was a union issue and it got shut down. Where are we on opening that again?

MacDowell: In the very beginning of December, we offered an urgent care process. It was up for 4 days before it was grieved. This is still in the bargaining process, and we are trying to work towards

the goal of moving this forward and opening it up again. I encourage you as the LFC to please help up with that.

Family member: Who would we reach out to advocate for this process?

MacDowell: Right now that would be the Teamsters Union.

Family Member: Do we know what the issues were?

MacDowell: Every employee has a 5% other duties as assigned. What I have been told by the union was that the urgent care exceeded that 5%.

Counselors have open door hours posted on their doors. Please double check on the efforts and the assisting that the counselors are giving.

Schreiber: That will definitely be looked at. Even though they are being tasked out to help with other areas their core job is for them to assist. **Action item

Video visit credits have not been coming through?

Baltzell: There was an issue that we were made aware of but are unaware if that is still an issue. I can contact HQ about that.

**On Monday 2/12 SCCC received the following notifications: "Upstream issue has been fixed and SVC Coupons are flowing out correctly. I've set the system to resend any coupons that would have been affected, they are going out now. Additionally, the system has been updated to detect this issue in the future (hopefully it does not happen again) and notify us if it happens." and "If you had any individuals or family members report to you they didn't receive their visit vouchers, please ask them to check again. The population received them but when they sent them to the system to go to family members they didn't go any further, hopefully the issue is truly"

Order sheets are only good through January 31st for union supply?

Schreiber: Typically when union supply comes out with a new catalog, they send the catalog with a stack of new order forms. We can check with property about that.

Family Member: We were waiting to submit an order due to this. **Action item

Credit where credit is due, Amend Advisory Council asked for the dip and pull ups bars and they have been ordered and are going to be installed soon.

Rumor is that facilities are reducing hours that the Incarcerated are working or their pay will be reduced after they just received a raise. Have you all heard anything about that.

Schreiber: I haven't heard anything about that, and we would hate to see that happen. Ms. Baltzell and I are always looking for more jobs and even creating jobs for more people.

Nolte: There was some discussion at the state level and there were jobs that were created during covid that are now being dissolved.

Family Member: The bill that was increasing the wages, did not pass. The wage increase was due to budget and unless they keep that in the budget it will go away.

Baltzell: We really hope that won't go away.

Schreiber: A lot of the stuff that we have been doing, and being tasked with for the Washington Way over the last 2 months have been amazing. Residents have conveyed back to me about custody staff and improvements outside the council and resource team. The Advisory Council is only a small part of the process. We now have 2 bins up top for donations. These donations are for releasing Incarcerated and allow them to leave with regular clothes instead of sweatpants and a paper bag. We have seen a change in the releasing Incarcerated when they get to leave with personal clothing on. We are also accepting toiletries for the releasing as well.

Men of compassion started last week. Through this program guys go up and spend time with those who are living in our medical and they now have the ability to have someone get them to the barber, the yard etc. Please stand by for more updates from CPM Baltzell and I regarding the Washington Way, remodels, and normalization.

Family Member: Can we please get the list of toiletries that can be donated and what clothing is needed.
