Van Ogle: The garden was one of our previous Captain's ideas. They had worked at Walla Walla and interacted with a lot of Individuals doing life sentences...this prompted his idea, and he brought that garden to SCCC in 2010ish. It's been going strong ever since. K. Bush: It's one of the most immaculate gardens, it's absolutely beautiful. They're growing things like strawberries, pumpkins, and a ton of vegetables. There are some flowers involved as well. **Arnold:** They have recently added a couple rows of succulents that survive yearround. Those gardeners are out there all day, sometimes just sitting there reviewing the area and other times, prepping the area for upcoming planting and weather. It gives them a nice break from everything.

Family Member: Can those with a life sentence qualify for these programs?

Arnold: With the policy change few years ago, we don't exclude people that have life sentences but those with a shorter sentence do get priority based on their ERD.

K. Bush: I think there are 2 or 3 currently in our BA program that are life without.

Nolte: are students working full time then doing this on their own time or is this part of their day?

Arnold: Kind of a blessing in disguise, but due to program space availability the BA program runs on the evening and weekends. This is a pro for those who do full time work...they can further their education and not have to miss out on having a job.

Family Friendly Updates

CPPC Branwyn Mansford

January Family Fun Night was a big hit. We made bookmarks with pressed flowers, contact paper, and various scrapbook items. It was very chill, very Family Member: How do you choose the timing of when you do certain events?

Mansford: When scheduling events, we also coordinate with the kitchen, visit room, culture events, and religious events.

The Significant Others event had 91 signed up. 60 tables were supposed to be used and less than 10 were on the waitlist. Unfortunately, attendance was low the day of, most likely due to traveling in the weather. We recently got a Cricut and used that to cut a bunch of shapes, people, lampposts for silhouette art. We also decided to do a flower activity where couples could make a bouquet together. There was also karaoke. This has gone over well at other facilities. but this group wasn't as into it this time. We played the newly wed game, which is always a hit. We had a few groups that went through on a rotation. Some of them had really funny answers. Overall, it was a good event.

The Spring Carnival is coming up on March 29th. This is a child friendly event and sign ups begin 2/14/2025.

SCCC added 2 more volunteers in January and have 3 additional working on their paperwork

We're going to have the connect project through rise to hope, and a meditation class beginning in the RHU this month. We have been trying to get more programs in there.

The meetings with DSHS are still going well. Again, these are monthly meetings that assist those within a month of release.4 February in particular has a large number of events, so we ended up doing Significant Others before Valentines Day and generally we try to do the spring event in April, but it landed at the end of March this year. Weather also plays a factor. My goal this year is to incorporate outdoor activities for an adult event.

Family Member: Is there a possibility that the outdoor area next to visit could be made into a picnic area where people could sit and visit without it being a special event? Arnold: Discussions about that started when Mr. Bennett was here, and we looked at WCC's area as well. Right now, this is a future budget item request. but in the meantime, we've purchased some outdoor picnic tables and a large event tent. These will allow us to do more this outside for special events while we continue to work out the dynamics of creating a more permanent structure. Family Member: would the big tent fit in that outside area? Arnold: Yes.

Statewide Family Council Update

SCCC LFC State Rep. Daphne Nolte

We got to meet our new DOC Secretary, Tim Lang. He told us his north stars are honesty, integrity, and transparency. He wants to focus on substance abuse treatment and knows the 20-25% of residents have opioid use disorder. He also spoke of making medication assistance available to everyone who needs it, saying it could possibly change lives of thousands in the system. Secretary Lang also said that he was particularly excited to hear about the Peer Certification program at SCCC. John Campbell from HQ spoke about restrictive housing. He said that's being looked at nationwide and worldwide. He also mentioned that it was a no brainier to choose SCCC for a program to reduce solitary confinement because of their con-do attitude and culture. It has been a success since the start in July of 2024. He is very proud of SCCC and amazed at what has been accomplished in the last 7 months.

We had a facility tour at SCCC on New Years Eve. There are so many great programs. We were able to go see Brigadoon where veterans are training service dogs for disabled veterans. We also saw Freedom Tails. That is a program through PAWS shelter. That is a 12-week program, and each dog has 2 handlers. They also go for adoption after they are trained. We also saw some of the classroom space, including the ones used for Evergreen. The classrooms are clean and modern like you may find in a liberal arts college. We also got to see some of the vegetable gardens, the bee keeping area, the skill builder classroom, and the hobby shop. We found an amazing guitarist rocking out in the music area. We met the new Chaplain, Christpher Hatch and learned a bit about his groups.

SCCC's Health Services and WOW have partnered to conduct the first quarter physical wellness workshop with an emphasis on

the silent killers. In addition, they are including talk on substance abuse and recovery challenges. They are expecting to have 100 participants.

SCCC has also had another fundraiser that included pizza, chicken, pies, and two liters of soda. Thank you to all who helped and donated their time.

New televisions have been purchased and installed in all the dayrooms. SCCC residents will be able to get the full line of channels offered in March. They are in the process of changing all stations from analog to digital.

Leon: The Solitary Confinement report was finally published. If anyone did not get it, you must sign up for the DOC communications. If you need help with that please contact me. At the state meeting there was quite a few questions about the budget and the Incarcerated \$1 wage as well. That was a bill that failed las session but was put in the budget so they are ensuring that that will remain in the budget. If not, there is a house bill currently introduced on this as well.

Announcements

The facility calendar has been updated. The API Heritage event has been moved to July 30th. That was at the request of the population.

There is a memo that will be posted and sent out via kiosk. We will be changing We will be changing the check-in hours for visitation. Starting in April first the check-in times there will be two sessions to check in for visitation the first one will be from 10:45 AM to 11:45 AM and the second check in time will be 5:45 PM to 6:45 PM. We'll update that on our website there will be notices for the public access and in the visitation room. It's going out to the entire population as well. We're not starting till April we wanted to give plenty of time for everyone to be aware.

Roundtable / Open discussion

Family Member: Why are you changing the visitation hours like that? Also, why was the selected evening time to start at 5:45pm?

Arnold: The changes have come from multiple requests with a number of complaints coming from the families. They would like more staff present in the visiting room and right now we have these long check-in times which caused one of the visitation staff to stay in public access to be able to view those check-ins. We checked with all the other facilities and us and WCC we're the only ones that did not have the more restricted checked in time. So, we just kind of got the alignment. Some facilities only allow the 30-minute check in time which we didn't think work for our facility and Sergeant McGinnis is on the phone. I did not select the hours they did it based on our current high-volume check in time, so Sergeant McGinnis do you have any comments on the 5:45 time? **McGinnis:** I do not have any comments on that.

Family Member: 5:45pm just seems so restrictive since count clears at 4:45pm. That leaves less than 2 hours. We have so many families that are extremely upset about it. I understand that it

doesn't start until April, but is it something that you guys are willing to think about a little more or reconsider your timeline.

Family Member: I there any way we can really look into these complaints and make sure they are valid because I'm sure you have heard some, but not concerning the entire population of families. This is definitely bad news for me.

Arnold: Thank you, we will take a look at the evening time.

Family Member: What about a 3rd check in, maybe before count

Family Member: I'm concerned about the mornings. I go see my husband before coming with my kids. If I get delayed for any reason, then I'm screwed. I think 1 hour in the morning is not acceptable. Maybe 10:45 -1:00, that sounds more workable.

Arnold: We'll look at the evening time. And we understand that this is a change. Like I said, we looked at what every other facility is doing, and this puts us in alignment with what they are doing and actually gives more of a check-in time. We understand that there's a change, so there will be grace time. So, if you show up 10-15 minutes late, we're not going to turn you away. There is going to be some grace time. The only person that will be allowed to deny a visitor will be the lieutenant. We understand traffic happens and there's things that come up with children, so we'll allow for that. **Family Member:** You said families were complaining, so is this the reason you're changing it? I really want to discuss that during this meeting and see if it's really an issue or not. And if not, I will ask you to not make the change. Was it your staff or are you really getting some concerns? I would like for you to be transparent about that instead of trying to blame it on the families

Arnold: I am being transparent and I'm not blaming it on the families. We had a couple of situations occur and what came out of that was for us to provide more staff presence in the visit room and for us to be able to accommodate it this is the best way that we have found. I hear your complaints we will take note of it, and we will take a look at it.

Family Member: That's a huge gap of time where you can't check in, but you can leave. Maybe adding tat 3rd check in time. You're saying its families requesting more staff present in the visit room. So, it's ither, we have more staff in the visit room, or we leave visit open. Maybe doing a survey like we have in the past...to see what the active families are wanting or what is more desired by the families. It's a lot of work to come with 2 babies 2 hors down the road, and trying to make that time frame. I think it's going to be more of a problem than we're realizing.

Family Member: Hypothetically since the check in window is so short you could have so many people show up that the visit room is completely full by 11:45 and then a few people would get turned away. But then people will leave at 12:30, what happens to those who were turned away and told to come back at 5:45? I can see this happening like back during covid. When visit was full some would consciously end their visit so others could come in. How will we mitigate that? This hypothetical situation will probably happen.

Arnold: We'll take a look at that and get some contingency plans.

Family Member: Notifications that are coming out. I get the meeting notifications, but I did not get notification about that December tour. I'm wondering how things are being shared and, I haven't seen the notification about you being promoted to the Superintendent. Is that an interim official? **Arnold:** My appointment is interim, that went into effect February 1st. The announcement was going to be done at this meeting. The tour we discussed at the last LFC meeting. It's not something that we put out to all family member because, per policy, it's only the elected members that are brought in for the tour: Co-Chair, Co-Secretary, State Representative, and statewide family council representatives associated with the facility.

Family Member: Okay, I thought that there was some discussion that it was not going to be just elected officials

Arnold: Policy allows elected officials to go in. It also says that the Superintendent can consider others on a case-by-case basis. So, if you want to send something in an e-mail if you're interested

in the tour to the family council e-mail box. Then we can put that on the list and whoever is Superintendent at that time to make a decision on that.

Family Member: Notifications...Are we going to be getting more emails, will one come out about you

Arnold: It will. The website has been updated. Ms. Carlson will also include it when she sends out this meetings minutes.

Family Member: Are you still accepting juveniles like Cheryl Strange said last fall?

Arnold: Yes, Green Hill is still coming. I want to clarify that although by state law, they're juveniles, these individuals are between the ages 20 and 25. They will be housed on our property but not with our population. They will be housed separately. I don't have a final date yet, but we have started construction at the facility to make space for them

Family Member: Visitation – If you came and missed the window but wanted to stay in Aberdeen waiting, could they have your cel phone number and text you if there is room?

Arnold: We will consider that.

Family Member: Fundraisers – I'm going to double back and suggest doing them on 2 different days. This is the 2nd one where they haven't gotten exactly what they ordered. I know it was a lot of work getting fundraisers going again but if it is broken up into 2 days then you're not having so many mixed up or incorrect orders.

Van Ogle: It is hard to find volunteer sponsors to do them, and this was the first time that we have done it since Covid in such a large fashion. I expected some mistakes to be made. Ms. Griffin made that corrections yesterday by going directly to the stores. Mistakes are going to happen. I can see how splitting it up into 2 days might help but I think what would really help is splitting it up by parts of the institution: X amount of units each month or quarter. I hear your suggestions, and we will take them into consideration.

Family Member: On a statewide level, there are other facilities that allow pictures to be taken in the EFVs. Not in the unit but just outside or in the processing area. Last meeting the LFC approved it. Families who don't do visits lose that picture option. Would it be helpful to know what facility is doing it?

Arnold: I will talk with the visit staff and see if that is something that we can accommodate or not. Yes, knowing who to reach out to and see how they are implementing it would help.

Family Member: Walla Walla. This only happened once but the Sgt. came into the unit with us and took our picture. It was then emailed to me.

Family Member: What is happening with video visit credits? We cannot get some this month. There have been no credits or even free options available this month

Arnold: Noone from SecurUs is on the line, but we can get that questions and send out an answer with the meeting minutes.*See attached document that was sent to families from SecurUs

Family Member: With the change in visit hours, how does that change check-in times for EFV? **Arnold:** We didn't discuss changing any check-in times for EFVs

Family Member: Our concerns about visiting times, when can we expect an update on this? **Arnold:** We wrote down all the concerns we heard today. We will take them into consideration and discuss it amongst the team. If anything changes, it will come out with the minutes.

Mansford: For those with kids...Would it be helpful on the event days where everybody has to leave and then come back during count, to have like a list of kid friendly things that are happening in Grays Harbor with some restaurants as well. This way you have a place to go if you're coming back or do you feel like most people with kids just leave after the event and go home?

Family Member: I think it would be helpful

Mansford: Okay, we will put one together and see if it's helpful for families.

Family Member: When is the next tour scheduled?

Arnold: We have not scheduled it yet. Policy allows for 2 tours a year, so I suggested we do one in the spring so the beauty of SCCC in the spring could be appreciated.





Your Guide to Understanding The 2024 FCC Order

In 2022, Congress passed the Martha Wright-Reed Act. This law directed the FCC to issue a new set of regulations governing incarcerated people's communications service providers like us. In the summer of 2024, the FCC issued those regulations, which are included in a formal FCC Order. This FAQ answers some key questions about the Order and its changes.

OVERALL

What services are impacted by the Order?

Phone calling and Video Connect are our only services impacted by the Order. Solutions like eMessaging, Text Connect, media, entertainment, and all other services are not affected.

Beginning in November of 2024, we will be removing all phone- and video-related transaction fees.

PHONE CALLING

How does the Order impact phone calls?

The Order reduces the overall rates that providers may charge for phone calls and video sessions. If you are at a facility where current rates are above the Order's rate caps, the rates will be reduced in the future. The timing of these rate changes depends on a variety of factors, including our company's existing agreement with each facility. Adjustments to calling rates are generally determined by the facility size and expiration of their current service agreement. You can expect rate changes to take effect beginning in 2025, and no later than April of 2026.

How will my loved ones pay for phone calls?

Although arrangements may vary by facility, family and friends will typically cover the cost of phone calls using funds from prepaid AdvanceConnect accounts. They can also enroll in TextPay and AutoPay to ensure their accounts always have funds available to accept calls from you.

Can I continue to call family and friends?

Yes! You will continue to initiate phone calls per your facility policy.

VIDEO

How does the Order impact Video Connect?

The Order specifies that providers charge for video calling on a pay-per-minute basis, which is functionality that we don't have right now, but are working to put in place. In the meantime, some facilities might choose to temporarily disable video calling in favor of different methods of communication. At locations that maintain our current Video Connect service, we may provide users an allotment of free video sessions, subject to facility agreement and policy. Any no-cost video calling will be on an interim basis only, until pay-per-minute Video Connect is available.

If offered at my facility, how will my family and friends book a free Video Connect session?

If sessions are available based on facility agreement and policy, they'll continue to sign in to their accounts to book video calls at least 24 hours (and up to two weeks) in advance, just like they do today. The only difference is that they will no longer be required to enter payment/vouchers and will be taken directly into scheduling.

Will my family and friends be allowed to purchase video sessions?

Purchased video sessions are not currently available, so only the provided free video sessions at facilities with active Video Connect service may be scheduled right now. Before pay-per-minute Video Connect is available, you may choose to supplement with phone calls.

Does the Order impact Video Connect sessions with attorneys or onsite video calling?

Correctional agencies generally control the availability of Video Connect sessions with attorneys and onsite video calling. You should check with the facility to confirm that the existing rules will continue to apply.

How will this affect facilities with video subscriptions?

Due to the Order's new requirements for alternate pricing plans, we must end our current subscription offering. Refunds will be provided to those who have unused portions of their subscriptions.

What will happen to the remaining funds my family and friends have in their Video Connect accounts?

We will issue automatic, one-time refunds of the total remaining funds in their accounts.

How will I know if I have a free video session scheduled by a loved one?

There is no change to this visibility – you will be able to see scheduled sessions at least 24 hours (and up to two weeks) in advance. Please check the video app on your tablet or a terminal regularly to view any upcoming sessions. Note: some agencies may post printed schedules in housing units.

ADVANCECONNECT

What is AdvanceConnect?

AdvanceConnect is a prepaid funding solution that allows your loved ones to pay for calls from you. Once their AdvanceConnect accounts are set up, they must fund them to begin paying for calls from you.

What are the advantages of AdvanceConnect?

- No credit check!
- Control They can continue to receive your calls (which they may always accept or reject) from you as long as funds are available in their accounts.
- Multiple lines They can add several phone numbers to their accounts so you can reach home, work, mobile, other relatives, friends, and more.
- TextPay and AutoPay We've lowered the minimum balance that triggers automatic funding from \$10 to \$5, and increased the maximum amount they can add per transaction from \$50 to \$100.
- Money management They can add funds to their accounts through securustech.net, the Securus Mobile app, a money-handling service such as MoneyGram/Western Union, or even by mailing a check.
- Account support They get 24/7/365 access to their accounts through securustech.net, the Securus Mobile app, or by calling Securus customer care.

For what services will my loved ones use their AdvanceConnect accounts?

They will use their AdvanceConnect accounts to pay for phone calls from you. They can also use these accounts to pay for video calls when paid Video Connect sessions resume sometime in 2025.

How do my loved ones add funds to their AdvanceConnect accounts?

Securus offers several convenient options for your loved ones to add funds to their AdvanceConnect accounts. They can quickly and easily add money to their AdvanceConnect accounts by:

- Signing in to their Securus account, selecting AdvanceConnect, and following funding instructions.
- Calling Securus customer care.
- Using MoneyGram or Western Union.
- Mailing Securus a personal check, money order or cashier's check.

Can my family and friends set up AdvanceConnect to automatically add funds to their accounts?

Yes! With TextPay and AutoPay, your loved ones can automatically add funds to their accounts when their balances fall to \$5. Best of all, they choose how much money is added so they're always in control of their calling expenses. Your loved ones can set up TextPay and AutoPay by signing in to their Securus account, clicking on AdvanceConnect, and following the simple instructions.

Does the Order impact my loved ones' AdvanceConnect accounts?

Their AdvanceConnect accounts will function just as they do today, but with a few enhancements. For TextPay and AutoPay, we've lowered the minimum balance that triggers automatic funding from \$10 to \$5, and increased the maximum amount they can add per transaction from \$50 to \$100.

SECURUS DEBIT

How do these changes affect my Securus Debit account?

As long as the functionality is available at your facility, you will continue to use Securus Debit to make calls.

Can I use my Securus Debit account to pay for other Securus products and services?

Yes! You may continue to use funds in your account to purchase all Securus services available at your facility.
