	Suggestion: Mother's Day event or Mother's Day Dance like at SCCC.	I currently provide a celebrating parent's event to provide an event for everyone. I understand not everyone has a mother figure or a father figure, so I keep this event pretty general.
	Is there a limit on number of events	Yes. General requirements say that there will be two child related events and 2 adult related events and adult and child events.
	Will any events be outside with the youth?	There is discussion going on about

		this right now. This is high on the priority list. Since this was reception, they didn't envision these events. We are looking at possible solutions.
	Suggestion: Would like the LFC to have input on the set-up of Family events before they happen.	No problem, we can address future events at the LFC meetings. I would love to hear input from the family members. The population at WCC is always involved in the planning of events and craft events, so I would love to hear family feedback as well.

Round Table Open Discussion:

Play Station – Is it all set up?

Answer: Yes, they are set up and ready to go when visiting is ready for kids to return. There is a separate area with a couch, TV, and Play station, plus multiple controllers. We will work with visit staff on scheduling.

Service animals – Do you allow service animals during the events?
