Supplies in Evergreen	Lack of toilet paper, paper towels, rags and cleaning solution for incarcerated individuals in the Evergreen unit	The TC units are verified the unit has plenty of cleaning supplies available as instructed when they arrive to WCC and they are pro-

These restrictions are not present in Cedar unit, which are also dry cells. It is unsanitary and inhumane to withhold necessary supplies from individuals for hygiene needs and for keeping their cells clean and as free of germs as possible. This restriction is unfairly visited upon one entire unit.

Please reinstate the practice of issuing one toilet roll to each individual who then may return an empty cone to receive another roll. Also, individuals need to have cleaning supplies in their cells.

vided the information on the processes. They all can clean cells starting as early as 0620 until 2140 recall with a request. Items are available throughout the day. Cleaning supplies will not be allowed in cells (i.e., solutions or tools) they are checked in and out for accountability.

Individuals are permitted freedom in personal grooming, provided it does not conflict with the institution's requirements for safety, security, identification, and hygiene.

- Shower daily and perform basic hygiene.
- Air out their mattress on laundry turn-in day by folding the mattress in half.

WCC TC Evergreen and Cedar are dry cells. The unit has dry cells and toilet paper is available for all in and near the restrooms. The unit porters clean the restrooms and showers throughout the day. There are plenty of cleaning supplies for sanitation.
