- An updated prosecutor recommendation was received, opposing release.

- Kenneth Reed was seen for a .100 hearing on June 25, 2025 at the Washington State Penitentiary.

- **Summary Discussion**
Corey McNally presented the case to the full Board.

- Kenneth Reed under the jurisdiction of the Board for their conviction of Assault in the First Degree in Okanogan County Cause 06355.

Mr. Reed assaulted his cellmate with a cell bar while discussing an escape plan. He was 31 years of age at the time of the crime and is currently 79 years of age.

Previous Criminal History:

Mr. Reed murdered the owner of the farm where he was employed.

Risk assessments show him to be a low risk to re-offend.

Mr. Reed's last serious infraction was in 2013.

Mr. Reed has not participated in programming.

Mr. Reed did not appear for his hearing, but it is noted that in his evaluation with Dr. Robtoy, Mr. Reed does not wish to be released as he has no support system, nor does he have the monetary or physical ability to take of himself.

- **Decision:**

The panel recommends Mr. Reed not be released and 90 months be added to the minimum term.

- **Reasons:**

- Mr. Reed has not participated in any change in programming, most likely due to his severe mental health disorder.
- According to Counselor Robinson, Mr. Reed has stated he does not want to be released. He did not attend the hearing today indicating he is unwilling to cooperate with conditions of supervision or requirements placed on him if released.
- Per the psychological evaluation by Dr. Robtoy, Mr. Reed has not demonstrated any significant change, and it is unknown if he could be successful if transitioned to the community, further, a change to the community likely would destabilize his mental health which has led to violence in the past.
- Refusing to attend his hearing does not allow the Board to make an accurate assessment of his rehabilitation and fitness for release.
- Mr. Reed has stated he does not want to be released, he has no support system, no way to support himself and has demonstrated an inability to care for himself while in prison, highlighting his lack of fitness for release.

- **Recommendations:**

- Mental Health Treatment (including any prescribed medications), if eligible.
- Remain infraction free and have positive interactions with staff.
- Participate in next Hearing.
- Develop a release plan/community support.

- **Next Action:**
 - Schedule a .100 Hearing approximately 120 days prior to PERD. A new psychological evaluation will be required for the next hearing.
